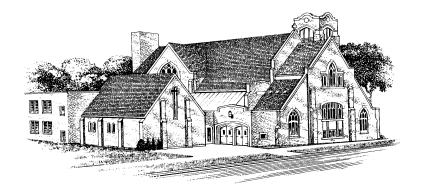

### **PASTOR KATHERINE ROOD'S REPORT**

Greetings, Saints of Glenwood Lutheran Church!

Partnering with you all has been a bit of a whirlwind on both sides of the pulpit I expect. It took a while, too, to find my legs and garner a measure of trust from Support Staff, Church Leaders, and members of the congregation. Some may still be a little wary, but for the most part it seems we have at least grown accustomed to one another and are beginning to feel hopeful about what might happen next.

#### What is an Interim Lead Pastor?

The work of an Interim Pastor is to first step in and fulfill all the roles and responsibilities of the preceding Pastor. In light of COVID, depending on levels of comfortability as we slowly emerge from the pandemic, my role also includes evaluating areas of need and coming alongside congregational leaders, and with them, discerning a way forward in preparation for a new Lead Pastor. The following reflect areas of my oversight and engagement these past nine months.

#### <u>Worship</u>

A steady increase in Worship attendance has joyfully been noted. Thank you to the Praise Band, all the vocalists and musicians who regularly give of their time and talent. Special thanks to Diane Moeller for her faithful work in contributing beautiful music to all our Worship Services across the span of the church seasons and for directing the Praise Band. Many people regularly attended our Worship Service in the Park, thanks again to the Praise Band and Diane and Gordy Moeller. Thank you to Gordy Moeller for directing the Adult Choir and to all the choir members who have shared the gift of their voices! The Christmas Cantata, The Shadow of the Cross on Good Friday, and all the Sundays in between have been blessed by your faithfulness. Thank you to Jess Listerud for directing the Sunday School Choir, a wonderful Children's Christmas Worship, and for filling in when Diane Moeller is absent. Thank you also to Heidi Polzin for filling in as needed and for directing the JuBELLate Ringers whose gift of music is heavenly!

Worship is hard to navigate without the many people who assist! Thank you to the Deacons, Ushers, Acolytes, the Altar Guild, and Custodians who prepare the space to welcome folks into our midst. A special word of thanks to Deacons Frank and Becky Evertz, and Shannon Bodeker our primary Custodian who keeps our building beautiful, welcoming and clean.

Thank you to Jeanette Rykhus for Worship enhancements through our Digital Media! From accompanying the Praise Band rehearsals, to Sunday and Midweek Worship Services, funerals and more, Jeanette's gift to ministry is ever-emerging. Glenwood Lutheran is truly blessed. I am especially grateful for the partnership of my colleague, Rev. Krista Lee, and our shared joy in serving the Gospel as we are led by the Holy Spirit! Thank you!

#### Pastoral Care:

Providing Pastoral Care at our local facilities at times remains a challenge, as are hospital visits. Even so, visits are made and happen more frequently. Worship at GRV provided by Glenwood Lutheran has resumed on the third Thursday of every month at 2:00 p.m. Come and join us!

Accompanying the saints in a time of loss is always a privilege and there are many at Glenwood Lutheran who help share the love of Christ with those who are grieving. Thank you to Donna Bogie, Jan Danielson, and all the Clusters who provide hospitality, comfort food, and prepare a space for caring fellowship; where would the church be without volunteers?

#### **Executive Committee and Church Council**

Working alongside dedicated leaders is a privilege! A huge thank you goes to President Teresa Jergenson, Vice-president Tina Blair, Secretary Marci Henke, Treasurer Curt Ogdahl and Donna Stelter, they have led faithfully and well! Truthfully, acclimating to how boards function and the work of the church is accomplished is a work in progress for me because every congregation interprets its Constitution and Bylaws differently! Still I am grateful for all the chairs and officers who give of their time and talent to serve Christ's people and mission.

#### **GLC Christian Education**

Christian Education for confirmation age students and the 5th & 6th graders was a primary area of concern and subsequent focus. We began a new program that required parent participation, student commitment, and members of the congregation to lend a hand. Thank you to all the parents who served as Guides for our small groups! Adjustments were made as needed (as in Advent, or for individual students), we began an online option for Guides and Students either not wanting to gather in-person, or in the event a group had a number of individuals who were ill and/or in quarantine. Thanks to Pastor Krista Lee it became a regular part of Confirmation, often utilized by Guides whether they met in-person or not. I dare say the Mentor Program was truly appreciated by most who committed themselves to the process. Wonderful faith connections were made that will last a lifetime, and many Mentors voiced looking forward to next year. Over the course of the summer, further streamlining will occur.

Thank you to all the volunteers, parents, student helpers, and Charity Vold who worked hard to bring Sunday School into reality this year. Special thanks to Jess Listerud, Anna Martinson, Tracy Swenson, Leah Oeltjen, Jenna Davids, Sheila Barsness, Amber Braaten, Randi Lee, Danette Disrud, Trisha Lohre, Jenna Myrom, Ben & Stephanie Grimes, Shjanna Pischke, Heidi Polzin, Kelly Danter, and Sara Larson. This dedicated group of leaders gladly welcomes teachers and volunteers!

#### **Transition Team**

The Transition Team, in preparation for the completion of Glenwood Lutheran's Ministry Site Profile, held several meetings, cohort opportunities, and One-to-One conversations to accomplish their task. Ultimately the final product serves as a primary tool for catching the attention of Pastors seeking a Call. Serving as resource and sounding board was a privilege as they put into words the revelations that came from you, the members of the congregation. Throughout this process, a deeper level of awareness and gratitude dawned for all the saints who make up Glenwood Lutheran! Members expressed a desire for change and engagement opportunities for all ages, but particularly for our youth. It became clear that Glenwood Lutheran was acutely aware of being On the Brink of Everything!

#### **Call Committee**

This group of individuals is tasked with the next phase of Calling a new Pastor. Having all the information from the Transition Team, they will soon begin the process of screening and interviewing potential Candidates. It's exciting to be at this juncture, but the Clergy shortage is real and they have their work cut out for them. Please hold them in prayer as they continue laboring on our behalf.

#### Stewardship:

Giving of our Time, Talents and Treasures is the right, duty, and privilege of every baptized child of God. As a church, we are charged with the mission of the Gospel, service to God and to our neighbor. Thank you to Greg and Charity Vold, and Rawley Kriel who brought Tina Turner live and on stage for our Stewardship Celebration last fall! I look forward to more new and creative ways of inviting people into joyful giving.

Thank you to Margaret Gylsen for serving as Glenwood Lutheran's Financial Secretary, and serving as an Office Receptionist/Secretary/Cemetery Treasurer/or whatever is needed! Some days you may catch her vacuuming the floor!

### PASTOR KRISTA LEE'S REPORT

"Ask, and it will be given to you; search, and you will find; knock, and the door will be opened for you."

#### Matthew 7:7

Dear Friends in Christ:

The Holy Spirit has been active at GLC this year. We said good-bye and blessings to Pastor Randy Chrissis upon his retirement in June, 2021, and hello to Reverend Katherine Rood as our Interim Lead Pastor in August. Last summer, we continued to live, work, and worship in the midst of a pandemic that surged in the autumn and winter of 2021. Our church programming moved from zero to 60 miles per hour in such a short time it made our heads spin.

#### WORSHIP

Slowly, but steadily in-person worship has increased in attendance since January 24, 2021 as the COVID threat has lessened. The highpoint for these past few years has been our Easter worship, April 17, 2022, when we had overflow attendance. It was exciting to see people who have stayed away because of the pandemic and now feel comfortable to come back into the building.

Our Livestream broadcast every Sunday morning has increased our worship attendance by including those who watch our services through YouTube, Facebook or our website. Glenwood Retirement Village shows the livestream every week in their chapel. These viewers increase our worship community. I have been told that there is a sense of connection with others who are in the physical space of the sanctuary as well as knowing that others are watching via livestream. This community connection through technology is re-defining the boundaries of what it is to be a church community. Soon we will have a way to name it.

The weekly radio broadcast continues to be a staple in our worship schedule. This broadcast covers the local area and we know it continues to be a source of comfort and community with those who listen

Weekly worship involves dedicated preparation from a variety of people on staff and through Boards. As a group, Pastors and staff spend approximately five to ten hours per week coordinating all aspects of the service. Each staff member has their own duties to prepare for Sunday. Pastors spend approximately 10-15 hours per week in preparation and study for preaching the sermon. Music selections are made to enhance the Scripture lessons and Gospel for each Sunday, Sunday School lessons coordinate with

the Revised Common Lectionary to reflect the Gospel, and all the moving pieces come together to provide a worship experience for those in attendance.

Glenwood Lutheran Church provides many special services throughout the year, aside from the Festival Sundays. These include, but are not limited to; Affirmation of Baptism, Chapel/Sanctuary worship services the afternoon of Thanksgiving Eve and the afternoon of Ash Wednesday, New Member Recognition Sunday, Senior High School Recognition Sunday, Bible Sunday, and Youth-led worship.

Pastors of GLC presided at 15 member funerals and 5 non-member funerals, burials, and inurnments in 2021-2022. We provide comfort and care for families while planning a funeral. The Clusters serve luncheons when requested.

In 2021-2022 Pastors officiated at 2 weddings which were off-site of the church building due to the complicated restrictions for COVID.

The community of Glenwood Lutheran Church welcomed 19 new members through the Sacrament of Holy Baptism in 2021-2022.

#### LEARNING

Several Bible studies resumed meeting in 2021 after restrictions were lifted. Zoom Bible studies were added to the schedule as a way to engage persons who worked full time and were not available during the day to attend Bible study. We will continue to look for ways to include Zoom in our learning programs at GLC.

A faithful group of book lovers meet the second Tuesday of every month to discuss the current listed book. We vote on a new list in the spring of each year, disband for the summer, and then resume meeting in September. All are welcome to join the group.

#### CARING

Pastors are called on for spontaneous pastoral conversations, crisis meetings, and to attend emergency situations. We will refer people in crisis to the variety of resources in the area and on-line.

Facilities in the area lifted restrictions for visiting on-site in the spring of 2022, so Pastors are now visiting members in the various homes in the area. We officiate a service once a month at GRV and serve the Sacrament of Holy Communion.

Prior to every staff meeting on Wednesday mornings, the staff is led by the Pastor to pray for 10-20 families of GLC.

### **REACHING OUT**

Our outreach ministry into the community is vast and subtle. Pastors are available for crisis care at the Glacial Ridge Hospital for members and non-members. Pastor Krista is part of the Crisis Team at Minnewaska Area High School and responds to area emergencies that affect the student population.

Pastors work with the Pope County Hospice for both members and non-members. Pastors are also available to Hoplin Hitchcock Funeral homes to preside at funerals for people who do not have a church home.

Worship in the Park begins the first weekend in June through Labor Day and reaches visitors, non-members and members. We also hold an 8:30am service for our radio broadcast.

Radio and Livestream broadcasts have been a way we have reached people who are either away from home, traveling, or passing through the broadcast area. Many people who are homebound or otherwise cannot be in-person participate in worship through this technology. For example: in the winter if there is a snowstorm, people can watch or listen through the radio or livestream broadcasts.

The Glenwood Lutheran Church building is a host site for community organizations who would otherwise not have a place to meet for their functions. We host the Boy Scouts of America, Girls Scouts of America, Pope County food Distribution, Glenwood Retirement Village auxiliary luncheons, American Red Cross blood drives, Waterama meetings, Be Kind weekly meetings, Synodical Events. We are an emergency site for the Minnewaska public schools.

This list highlights the active ministry within Glenwood Lutheran Church. If you would like to be part of the ministry at GLC, please don't hesitate to call the Pastors or reach out to the church office for more information.

### **TERESA JERGENSON, COUNCIL PRESIDENT REPORT**

Dear Members of Glenwood Lutheran Church,

As I reviewed the last several Congregational President reports, the words *transition and change* have been used and continue to be used at Glenwood Lutheran Church.

"Change is Inevitable. Change is constant." - Benjamin Disraeli

Brad Vold, Congregational President in 2018-19 asked the congregation, What kind of congregation do we want to be? **Pay-the-bills** congregation who frame religious giving in mostly unspiritual terms as necessary to keep the doors open and meet the budget. Characteristics of Pay-the-bills congregation are: money is scarce, must pay bills in order to survive, focus is internal and insular, and you must do your fair share. OR **Share-the-vision** congregation who tend to connect and integrate money and spirituality. Characteristics of Share-the-vision are: not rich, but have enough, dare to dream and grow the faith, focus is external and global, and tend to partner and grow in faith.

I believe Glenwood Lutheran Church has answered the question: Despite the challenges of COVID, under the leadership of Eric Randleman, Congregational Council President in 2019-2021, leadership was able to continue the outreach of livestreaming our services and growing the faith.

With the retirement of Pastor Randy in 2021, it led to creating our Transition Team and the team listening to the congregation to help answer the question Brad posed: *who is Glenwood Lutheran Church and who do we want to be*. Based on the congregation's feedback, *Share-the-vision* is what we would like to strive for.

At the same time the congregation was giving feedback to the Transition Team, our boards and council diligently worked on learning our current processes/policies. Our constitution directs us on those roles and responsibilities and as any change in leadership, it gives us new perspective and with safety measures that were taken during the height of the pandemic, we were unable to do some of the tasks.

As we referred to our constitution, each board took on additional responsibilities as we continued moving through the pandemic. Sunday School, Confirmation, Adult Education restarted in person and/or virtual.

In person worship continues to grow with the reintroduction of acolytes, deacons, ushers, altar guild, readers, praise band, adult choir, bell choir, etc.

The congregation also approved the remodeling of our parsonage. The process has started in hopes to be completed in the middle of June.

The personnel committee was reintroduced. The personnel committee evaluated staffing needs, reviewed/created job descriptions in addition to reviewing the Synod Compensation/Benefit Guidelines for our Pastoral staff and bringing them to at least the minimum of the guidelines.

The personnel committee reviewed the needs of our congregation, we concluded that our support staff have been working short-handed. The personnel committee has proposed added positions/hours/wages to meet the desires the congregation has for growing the faith with our youth, young adults, and adults.

As we prepare for a new lead pastor, we need to realign the Pastoral Compensation/Benefits to the minimum and sustain the compensation/benefit package, as we are currently behind guidelines. These initiatives are included in the proposed 2022-23 budget and going forward.

The congregation elected our call committee. They have begun the initial steps in searching for our new Lead Pastor based on the Ministry Site Profile (MSP).

As we envision, being a **Share-the vision** congregation, we will need to continue working together. A Share-the vision congregation it can be through financial giving, volunteering, relational generosity (social networks, being engaging with other people), neighborly generosity (expressions of care, hospitality, assistance with chores), and self-evaluation (do you see yourself as generous?).

I understand the challenge of financially giving, but if each family gave a small treasure and/or increased by only a small percentage it would move us closer to being a **Share-the-vision** congregation.

Our congregation demonstrates time and again the level of generosity within our members. This not only includes giving of treasure, but giving of time and talent.

So no, we are not the same congregation we were last year, or ten years ago. Times have changed, things have changed. We have changed since last calling a pastor and we are "On the Brink of Everything". I look forward to continuing to change and becoming a **Share-the-vision** Congregation.

In closing, I want to thank you for the opportunity to serve as the Congregation Council President. Thank you to Interim Lead Pastor Katherine Rood, Pastor Krista Lee, staff and the many boards/committees (past and present) and the many volunteers of Glenwood Lutheran Church. I am proud to say I belong to a church that continues to change and look at new and different ways to remain vibrant and spread the word.

#### **Call Process**

In light of Pastor Randy's retirement, Pastor Kathryn Skoglund, SW Minnesota Synod, was present to speak about the Call Process.

First step to find an interim pastor. She informed that there are very few available and lay leaders may be necessary. Patience & prayers are necessary.

Second is to form a Transition Team to determine what kind of person is needed and write a Ministry Site Profile for GLC.

Third is to elect a Call Committee that will interview candidates.

Question from Bob Gandrud, is there more urgency in light of few interims? Pastor Skoglund stressed importance to be very deliberate in describing what & who we need.

Question from Randy Hagen regarding compensation for the interim pastor. An interim pastor is paid at the same level as the Pastor that is leaving.

Question from Ron Cin regarding the role of the Transition Team. They will gather information from the congregation through small group meetings, survey, etc.

Question from Eric Randleman regarding a timeline for when an interim might be available. Working for as soon as possible but it's hard to say.

#### Update on Phase II Debt Reduction Fundraiser, Randy Hagen

The goal was to reduce \$450,000 debt from 2015 Building Renovation Project, as well as \$100,000 debt from elevator and air conditioner repairs.

The repairs have been done and are paid. Renovation debt has been reduced to \$220,000.

Going into Annual MeetingRemaining Building Loan Balance\$220,434Renovation Account Cash\$18,650Unpaid Pledges(expected over 4 years)\$110,585Projected Loan Balance after all anticipatedUnpaid pledges and cash applied\$91,200 to be raised in pledge drive.

An anonymous donor has agreed to match up to \$45,000 for any cash gift or 3-year pledge made by Dec. 31, 2021, for the purpose of encouraging commitments to pay off our debt.

Before the end of the meeting a text message was received that would give \$22,500, leaving just \$22,500 for the congregation to raise.

Curt presented the annual Balance Sheet, as well as the Profit & Loss/Income Statement.

#### Presentation of 2021-22 Budget, Dion Harste

Considering the COVID year and barely back to in-person worship, the Giving goals remain the same as prior year. Changes to expense have been "right-sized" according to current activity.

Since no recommendations have been through the Church Council, the budget cannot be voted upon today. Choices are to "refer to Committee" OR to pass last year's unbalanced budget.

M/S/P Dion Harste/Jerry Wright to refer the report to Council with full powers to act.

#### Board/Committee Reports: included in Annual Report.

Pastor Krista Lee addressed the congregation briefly, expressing that she feels very called to this process and transition and will do her best to serve & do her job.

Pastor Randy also spoke briefly, expressing his appreciation for his time at GLC. He also left a reminder that the year 2030 is the 150<sup>th</sup> Anniversary of the congregation and recommended that a budget should be prepared for celebration.

Pastor Krista Lee led the closing prayer.

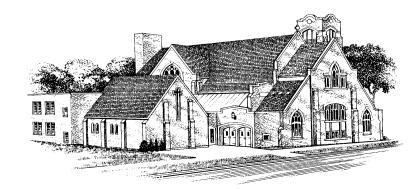

### 2022 Audit Report

Glenwood Lutheran Church Board and Congregation

After reviewing a sampling of the financial data for the fiscal year ended 04/30/2021, no substantial issues were found.

We do recommend the following changes:

-purchase order be filled out before actually ordering supplies

-have one of the pastors initial the timesheets for staff, before the timesheet are sent to Wangsness-Ogdahl Accounting

-possibly going to just one credit card, if hiring an office manager, they could be responsible for ordering supplies once the purchase orders are received

-there are two accounts that need to have new signature cards filled out, due to people no longer with GLC, they are GLC Helps and Community Garden accounts

-hiring an accounting firm to perform the audit, at least every few years, they have more knowledge of current accounting procedures

-begin the process of writing out procedures, by having current staff write out what they currently do and adjust to make any changes needed

### Phase II Debt Reduction Fund Drive Update

Approximately two years ago, the Phase II Fund Drive began with a goal of raising nearly \$550,000 to pay down approximately \$450,000 of building debt remaining from our church renovation project, plus an additional \$100,000 in elevator and air conditioning repairs.

Due to the overwhelming support from our congregational members, we have now paid for the elevator and air conditioner repairs and we are in a position to retire our remaining debt before the end of 2023.

We presently have a remaining building debt of \$43,303.14, but we also have a positive cash balance in our renovation account of \$16,153.05. This is cash we are holding in reserve to ensure that we can make our monthly loan payments of \$2,790.00 should we experience a monthly cash shortfall, but all of it will eventually go towards debt reduction. If we applied all of the \$16,153.05 cash today to the \$43,303.14 debt, our remaining loan balance would be \$27,150.09.

We are expecting over \$60,000.00 in pledges to come in over the next 3 years, which will be more than enough to pay the remaining debt. We do not anticipate collecting all of the remaining pledges due to members changing financial conditions or other unforeseen circumstances, but we do anticipate collecting enough of the remaining pledges to pay off the loan.

# Technology Update

# And the Transition Continues...

Preparing for this year's annual report began by reviewing the 2021 report. All we can say is WOW, was that a year! This past one perhaps as daunting, but different. Most challenging was **transitioning**, from "closed to open," from one lead pastor another, one version of ProPresenter to another, etc., you get the idea.

It was especially helpful to have been in a state of flux, prior to all the change that this year has brought, and the future holds. It will prepare us well for making



the transition when the time comes for a new pastor and any other changes. One example, we did not take the time to explain to Pastor Katherine the restraints (that we have all taken for granted for so many years) on the early worship service for radio broadcasts. There were a few "bumpy worship services" and we are grateful our radio broadcast listeners, and the radio station are so patient with us.

Acquainting new personnel to all our systems has been challenging. We did develop some "best practices" to assure confidentially and improved security. We had in most of our vendors to help with many of these processes. We developed an accounting of office information services, church-wide digital services, and subscriptions that the church uses to assist in the **budgeting** process. We also did some forecasting into the future needs of technology for the church. We use nearly every pricing model, in one form or another. It makes budgeting and forecasting more complex. The most common software and media licensing pricing models include:

We all take very seriously our commitment to our radio listeners, our livestream viewers, and those using their computer to access either the radio or livestream services. We did some evaluation and set a couple goals in these regards. We determined that we needed competent **sound** operators—all four of our platforms, in-the-pew, in-the-park, the radio broadcast, and livestream, depend on good sound quality. During "Covid" Eric Randleman had acted as sound operator for approximately 14 months, to keep staff's exposure limited. We had only one former operator willing to come back after Covid. We had to recruit new operators, with the help of the pastors and the Music & Worship Committee.

We approached the trustees/council and explained that we wanted to increase the stipend paid to our sound operators, to improve recruitment and retention. Sound operators are paid out of the Radio Broadcast/Livestream fund, which means they are paid for by those who sponsor radio and/or livestream coverage for worship services. Having no objection, we set about recruiting three new operators (we had one, and two backup operators). It was rough going, people do not realize how complex our system is, and most are unfamiliar with sound amplification in general. But, we are really happy with the crew we now have (see who they are on page 6 of this report, the list of operators).

Problems with our wireless transmission to the Radio Station during live broadcasts facilitated the updating of the software on our broadcast laptop in the balcony. We-formatted the hard disk, updated to the Windows 10 Operating System and then needed to update our wireless transmission software. These updates resolved the issues we were having, and we thank God for that, it was proving a frustration to all. It was also time to update our live production & presentation software, ProPresenter from version 6 to 7. They changed the pricing model, costs increased, as did its complexity of operation.

We needed to replace one of our stationary video cameras with a second remote-controlled **livestream** camera. We changed over to a new (unmanaged) switch with PoE capabilities, and connected cameras to our network with less cabling. We also added a wireless access point in the balcony. Thanks to the continued generosity of the late Lowell Lee (Pastor Krista's father) and Ken & Nancy Moe, we were able to add that camera. This next year we want to replace our last stationary camera, with a third. They cost over \$2,000 so it is why we are adding one at a time. The remote-control feature allows one operator to control all three cameras from the same computer in the balcony simultaneously. We are having stability issues with our cameras mounted on/under the balcony, so this third one will be installed elsewhere in the sanctuary.

We expanded our livestream "channels," to include one for education, and added educational videos for those unable to attend weekly confirmation sessions. We currently have four channels.

Our livestream audience has continued to grow gradually, even now that we are back to in-person worship. The quality of our sound and video is very good. Our livestream worship services are simulcast live to our website, YouTube, Twitter, and Facebook, as well as the Box Cast streaming app (so you can watch using a smart TV, Roku, Amazon Fire, or Apple TV streaming devices). We can roughly expect 200 persons to watch our livestream services every week. We have submitted numbers to the pastors, council president and the trustee board for nearly two years now. Surprising is that we've not lost users, there is a slow gradual growth, also surprising is the number of users that have moved to other streaming methods, versus Facebook. We've offered those the entire time, but we think driving users to the website exclusively for things like confirmation and funerals has allowed users to get used to other streaming methods, which are superior to Facebook and Twitter.

Our online presence includes our website (glenwoodluthean.com), an online photo directory, a Facebook presence (page and groups) and a YouTube channel. We send out Tweets and Instagrams, as well as post on Google and Pinterest. Our website is "mobile ready," as is our online giving website page (also accessed via a QR code or the Vanco app on mobile devices), and we send out two weekly e-mail newsletters. We did finally livestream from a park service last summer, and hope to do so a few times this summer. Respectfully submitted, Jeanette Rykhus, Communications Coordinator

### Youth Board Annual Report

The Youth Board again participated in the Souper Bowl of Caring and was able to raise \$319.40 for our local food shelf.

With money fundraised, along with a donation from WELCA and an anonymous donor, the Youth board will be working with a few youth to paint and decorate the southeast downstairs classroom. We are hoping to make this a 'youth friendly' atmosphere to give them a place to sit and talk or have meetings. Our church is known to say "There is a place for you here" and we hope to include youth in giving them a feeling of belonging.

This past fall, there was a fall get together held at Barsness Park for the 5-6 graders with games, treats, and devotions. We were also able to provide DQ treats for the Wednesday evening youth classes as well as the mentors that worked with grades 7-9. We appreciated those that stepped up and were mentors to students. This program was a way to connect the youth with others in the congregations.

We have and will continue to work with the Education board to help put on programming and youth activities. We would like to see these boards work more closely together in the next years.

As with the last couple years, we will have a lot of changes happening as we call a new pastor. There is uncertainty on what the new Pastor would like to see in the Youth programming so as a board we are still unsure of our direction, but we do know that we need to REBUILD connections with the youth of the congregation. Congratulations to our graduating seniors! Another change for families as the graduates will be moving onto other plans. We will miss seeing their faces. We will be honoring these young adults with the Youth Board sending them off with gas cards to come back and visit anytime!

In closing, we all need to remember that things take time to build. There will be hiccups along the way, but if we all work together it will happen!

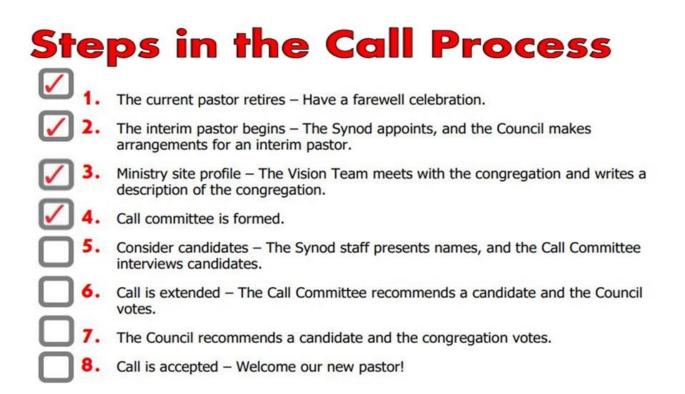

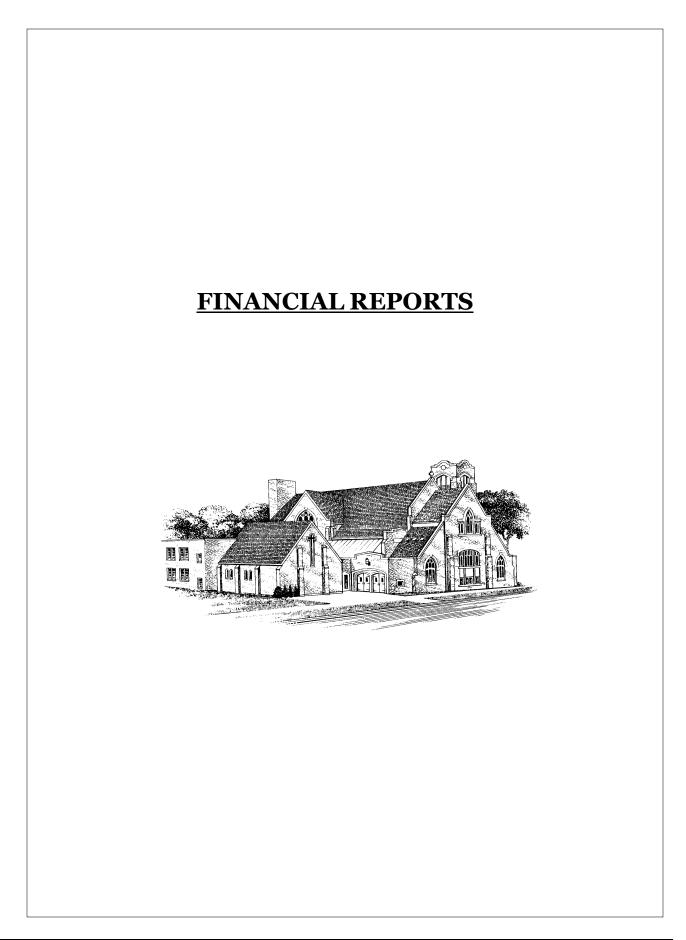

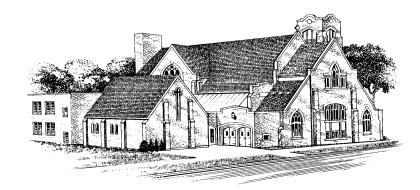
# Budget Motion

Change and the need for creativity have become constants over the last year and a half in many aspects of life, including the church. This was the case for **Living Christ Lutheran Church** in Flagstaff, Ariz., even before a global pandemic caused many of us to rethink what it means to be church. Generosity from all three expressions of the ELCA (the churchwide organization, the Grand Canyon Synod and members of Living Christ) helped turn a congregation "on the road out of town, near the mall" into an online presence reaching over 500 people a week from Phoenix to the Philippines. (Read more about Living Christ in the current issue of "**Stories of Faith in**. **Action**" at **ELCA.org/SOFIA**.)

Many other congregations have found new ways to connect both when inperson worship was impossible and when congregations began to return to their sanctuaries. Generosity, especially through Mission Support, helped us find and support these new ways of being connected. Early in the pandemic, ELCA Worship launched the "Worship in the Home" webpage, with Scripture, hymn links, prayers and reflections for each Sunday. These resources were and continue to be used in congregations across the ELCA—even at <u>Sitka Lutheran Church</u> in Alaska, whose members printed and handdelivered "Worship in the Home" resources to fellow members without internet access.

Change and creativity have taught us many things. As Pastor Sandra Rudd of Sitka Lutheran Church noted, "The pandemic was a stark illustration of the fact that the that, but we didn't fully know it until we that there are many ways to be connected as the church." Throughout the pandemic, the ELCA has changed and adapted, doing of the generosity of its members. Even now, you may be gathering in a new way for your annual meeting, to discern how you with your congregation to do ministry in that your gifts of time, talent and resources have helped create new spaces beyond our walls and buildings where we continue to worship, serve and love God and each other.

Bishop's 2021 Annual Report Rev. Dee Pederson, D.Min.

> "God has placed us in cities, farms, and towns together.... The Risen Christ surprises us as we plant God's Word in the world.... By God's grace, together we have what we need."

These words from our synod mission statement provide both grounding and direction as we complete a year of significant change and look ahead to the future. And first I want to say **Thank You!** for your congregation's participation and leadership, and for your partnership with one another across our synod. I am inspired by your witness to Jesus Christ and grateful for your dedication! As I share this first annual report, there are key insights in this statement that I want to lift up.

God. I know: that is not a surprising place to begin, is it? But all too often, we do not begin with God or God's Word; we begin with us. Or me. And given the year we have just been through, that is understandable. There are so many concerns that weigh on our hearts. We have mourned the loss of loved ones, struggled with pandemic protocols and illness, seen our kids be on-again off-again with their schools, navigated worship and devotions online, worried about attendance and offering, waited for a pastor to come to lead us. But during challenging times especially, it is vital to begin with God, just as the stories of God's Word do:

- In the beginning God created. Genesis 1:1
- In the beginning was the Word. John 1:1
- \* The grace of the Lord Jesus be with all the saints. Amen. Revelation 22:21

As we consider how much the world has changed in the last 2 years, and as we consider the challenges our congregations and communities face in greater Minnesota right now, it is easy to get stuck on us and our problems.

Yet your congregation is not here by chance. It is God who planted you where you are – whether that was 155 years ago, 45, or 5. You have been baptized into the Holy Trinity, who now sends you to serve each other and your community for a time such as this. God is calling you. The Risen Christ does surprise us as we plant God's Word. God's grace will provide what you need. *"It is the Lord your God who goes with you. And God will not forsake you or leave you."* (Deut. 31:6).

*Together.* "Synod" literally means "walking together." Planted in cities, open rural country, and towns, no two of our congregations are identical; we are different from each other. We have different histories and traditions. That can lead us to think that because we may not have certain things in common, that we don't need each other. After serving in this Office for only 4 months, I have been blessed to see the varieties of gifts the Spirit has poured out on each of our congregations and rostered ministers. And one of the things the pandemic has taught us is that we are better together. This year we have discovered that "togetherness" in new and important ways:

- Presidents & lay leaders making connections and sharing best practices as they meet together.
- Rostered ministers forming long and lasting relationships via zoom, in person, in text studies, and conference gatherings for support, encouragement, and prayer.
- Neighboring congregations meeting together to explore how they might share ministry programming and
  pastoral care and leadership.

Together, your synod staff has been walking with you as we have been in a time of transition:

- I am so grateful for the leadership of Bishop Jon Anderson over these past 18 years. His legacy provides such a strong
  foundation for this synod as I have begun to serve in this new role.
- Synod Minister Pr. Stephen Cook will continue to serve in his call as pastoral staff and will relate to conferences in the northern tier of the synod.
- Synod Administrative Staff includes Tammy Schacher Executive Assistant to the Bishop, Office Manager, and Call Process Administrator; Kristin Bakeberg – Communications Coordinator; Maggie Berggren – Administrative Assistant; Carla Klawitter – Temporary Administrative Assistant.
- Transition Synod Ministers Pr. Dwaine Bruns, Pr. Art Wiese, Pr. Stephen Rasmusson, and former Synod Staff member Pr. Linda Pedersen – sustained conference call processes and will conclude their transitional ministry at the end of January.
- \* Gifts of Grace staff Pr. Andrew Hermodson-Olsen and Pr. Kelly France.
- Pr. Keith Pearson, ELCA Planned Giving Coordinator a position funded by the ELCA and deployed in the synod.
- Sister Sarah Hausken now serving with the churchwide Deaconess Community after working with our synod for 21 years.
- Pr. Troy Pflibsen Director for Evangelical Mission (D.E.M.) a position funded by the ELCA and deployed in our synod.
- Pr. Heather Culuris, joining our pastoral staff January 1, 2022, will relate to conferences in the southern tier of the synod.

Together, your staff team has been doing a fantastic job of focusing on candidacy, interim ministries, call process, and the leadership transition. At the present time, there are 54 out of 230 congregations that are in some point of transition – the highest number ever. If you know someone in your congregation who has the gifts for full or part-time ministry, please be bold enough to encourage them; it may be the Spirit's way of calling forth a new leader. And if you have a rostered minister leading your congregation right now, please express your appreciation to them and let them know you are grateful for their ministry.

By God's grace, together we have what we need.

I return to the place I began: gratitude. Thank you for your continuing and generous financial gifts for Mission Support that sustain the ministries of this synod and our many partners locally and around the globe. We are grateful to all who have shared gifts for Gifts of Grace that enhance the financial well-being of our rostered leaders. In addition, this year Lilly Endowment, Inc. has awarded us a new grant that will assist rostered ministers impacted financially by the pandemic, as well as assisting congregations who will explore partnerships with neighboring churches. During a change in leadership, I am grateful for the staff and governance leaders who have ensured that we enter 2022 on a solid place financially and begin a process of envisioning how God's mission is leading us in new ways into the future.

Finally, thank you for your prayers as I begin serving in the Office of the Bishop. I have been overwhelmed by the power of your prayers and encouragement during these first four months of leadership and pray that I serve you and God's mission well as the synod's pastor. Know that you are in my prayers and in my heart. Know that I welcome and seek your ideas, feedback, visits, conversations, and insights as I begin the responsibilities of this ministry. I give thanks that, by God's grace, together we have what we need.

# GRV 2021 Annual Report

### Annual Report of Glenwood Retirement Village for FY 2020 10/1/20 to 9/30/21

This report summarizes the activity of all three corporations: Glenwood Village Care Center (which includes Parkview Court), Glenwood Plaza and Glenwood Retirement Home Foundation. Glenwood Retirement Village wishes to thank our member congregations for the support you have shown in the past year.

The Covid-19 global pandemic has continued to cause upheaval and challenges in Senior Care since March, 2020. In the past year we have dealt with a drop in occupancy at both the Care Center and Parkview Court related to the pandemic. Staffing shortages have continued to plague most senior care facilities as the pandemic wears on. We are extremely grateful to our employees who have remained with us throughout the year and provided much needed care under challenging circumstances.

Vaccines became available to residents and employees in January and a majority of residents and staff took advantage of the opportunity to receive the two-dose Moderna vaccine provided for us. The use of PPE continues with face masks and eye protection required for employees. CMS relaxed visitation restrictions for family members and friends during the year and we no longer need to lock our doors to visitation whenever anyone tests positive. This change in regulation decreased the sense of isolation that residents felt during the first year and one-half of the pandemic.

GRV served over 125 seniors with health and rehabilitative care, memory care, assisted living and housing in the past fiscal year. We had 105 employees on a typical payroll.

The average age of a resident in the nursing home is 86.8 years and average age at Parkview Court is 87.1 years. The majority of residents admitted to the nursing home come from Glacial Ridge Health System. The majority of admissions to Parkview come from a private home or apartment.

GVCC is currently licensed for 64 SNF beds. We have 52 single rooms and 6 double occupancy rooms. Census has declined in the past year, primarily due to the impact of the Covid pandemic. We plan to lay-away 14 beds in the coming year due to the staffing shortage and will then be licensed for 50 beds.

Total resident days for the Care Center: 16,761 or 45.92 residents/day average (Last year = 18,130 or 49.54/residents per day). This is an occupancy rate of 72% versus 77% one year ago.

The nursing home currently has a 4-Star rating from CMS. This is based on multiple criteria including RN and other nursing hours, survey results and quality indicator scores. (See Nursing Home Compare on the CMS website for detail on any nursing home in the US.)

#### **Glenwood Plaza**

There are 30 townhomes available for rent. Occupancy was 93% on 9/30/21. There is an active wait- list and the two vacant units will be rented in early 2022 upon completion of renovation.

In 2017 the governing board voted to move to a "rental only" option as units vacate. There are presently 13 units rented and the other 17 units have the lifetime lease option. Monthly rent currently is \$1,269 or \$1,623 for the larger units. The current monthly service fee is \$599 for those with the lifetime lease option.

#### **Employment Opportunities**

We thank our congregations, board members and auxiliary for the contributions of the past year. Your financial generosity and your gift of time as a volunteer is truly appreciated. As mentioned earlier, staffing challenges have been exacerbated by the pandemic. Please consider GRV if you or a family member is looking for employment. We recently improved our hourly wage and have full or part-time needs in dietary, the activity department and in all nursing areas at the Care Center and Parkview Court. Please give us a call or check our website for employment opportunities. The work is truly meaningful and worthwhile!

# FIRM FOUNDATION

This past year at Luther Crest, we began resuming in-person programming with the help of our fully-staffed summer team of 46 people. As a thank you to our hard-working and dedicated staff after a challenging year, we were able to offer them scholarships to be used as funds for schooling or additional aid.

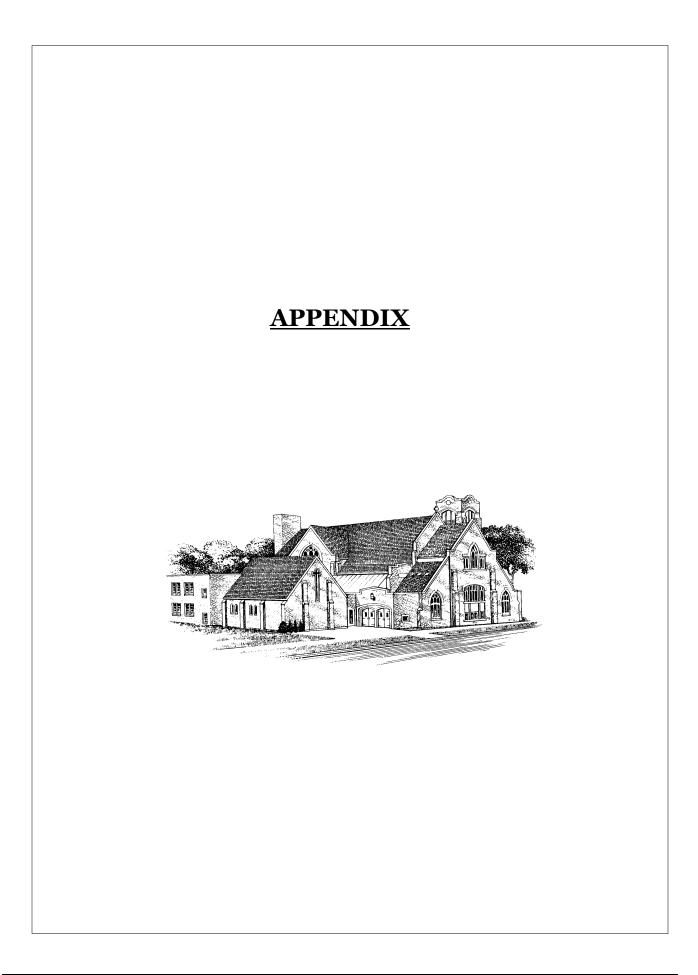


### **BOLD TRANSFORMATIONAL FAITH**

As for our Bold Transformational Faith Program (with Cross Roads Camp and Retreat Center, NJ), we were able to adapt to the ongoing changes that we are seeing in congregations as they shift back to in-person worshipping and education. As the BTF program was built to do, we were able to format the programming to be utilized in both an in-person format, an online format, or a hybrid format.

We have developed our website, www.mybtf.org, to be a main hub for all participants to gather, gain information, reach out to our staff, and receive materials through personalized accounts. BTF now offers Sunday School video options, camp songs for use in worship, training for Faith Formation Leaders, training for Church Leadership, Sunday School and Confirmation curriculum, a podcast, children's messages, worship assistance, family newsletters, and a personalized webpage for each church involved. We have organized these options into different "bundle" options that allow congregations to pick one that fits their context best, or build one that encompasses their needs. Last school year we had 25 churches involved, and this year 11 so far and increasing. Congregations from Minnesota to New Jersey are continuing to reach out and find ways to join into the program.

As uncertainty and, at times, chaos continues, our commitment to provide quality experiences that live out our mission continues. We will go into 2021 ready to provide Christ centered experiences, grow communities, and foster stewardship through youth retreats, summer camp programming, BTF, our summer ministry team and more. #### 2022 Cluster Lists

All members of GLC are assigned to a cluster. Some members have asked that we publish the Cluster Lists so you can see what cluster your household is in, and who else is in your cluster. If you see an error or need to make a correction, call the church office, 634-4514.
